- i. Training: KVK had conducted 33 no of training programme for farmers and farm women, 5no of Extension functionaries, 7no of rural youth and 6 no of vocational training programme involving 1075 nos of beneficiaries.
- ii. Front Line Demonstration: KVK had conducted 12no of FLD programme (Other than Oilseed and Pulses) and disseminated the latest proven technology in different blocks of the district.
- iii. On Farm Testing: KVK had conducted 05 no of OFT involving 35nos of beneficiary.

Agenda- 5 – Suggestion of the Members

After completion of all the presentation of individual Scientists the chairman requested the members to comment on the activities and invited suggestions. The suggestions were made by the members are listed below:-

District forestry officer

Suggested that, different agricultural & allied activated should be done in convergence mode with the line deptt. Officials of the district. He stressed on value addition of local

mug as the cropping pattern of the district is followed by paddy & mug cultivation. He suggested for forage crop cultivation so as to develop the grass land of the district. He on the value addition & market at gur as sugarcane the major cash crop of the district. He emphasized on agro forestry with the species like Acacia as a crop. He requested to KVK to test 900 nos. Of soil sample in the laboratory. He also told for dairy farm by making a group through farmers producer organisation for diversification agri. allied sector in the district.

2. **DDA Nayagarh** stressed on the convergence mode of work between the KVK & the line deff. Of the district. He suggested that, this convergence would be successful by develop the action plan where the technical assistance of ATMA can be used. He also suggested to disseminate the technology at a faster rate.
3. **DDH Nayagarh** requested for providing training list to the Horticulture Deptt. So that they can involve in the training programmes. He also suggested to study the weeping quality of marigold. He also mentimed on the cultivation of spinegowrd with trlly & covering system .
4. **ADR** Suggested that, horizontal spread of any technology should be included in the presentation. He suggested to the scientist plant protein to to continue his OFT on And add natural enemies in the FLD on for better results.
- 5 **THE PD** Watershed emphasized on convergence programme for doubling formers income steps should be taken for popularization of locally produce Mung variety in the district work should be unclrtation value addition of brinjal as huge quantity of bringals is avail in the market. He suggested for bond cultivation. Arhar, ridge goued, Spine etc. Should be cultivation on the bond to achieve a good economic return.
6. **LBM** Suggested that, Kvk & line deptt. Bonkers convergence group app should be developed for linkage banker exposure farmers field for commercial agriculture.
7. Deptt. Of Veterinary, Suggested that KVK should promote the Banaraja bird through backyard poultry rearing & he also emphases forming in the on goat forming in the district.
8. **Fishery** stated that a convergence made work should be there to develop the frmng in the district.
9. **DSWO** on mission Shakti group involving around 6000 no of SHG group in the District. He suggested that, KVK should take initiative to conduct training programme on grain standard specially HYV seeds.
10. **Pulse specialist, Nayagarh** Suggested for chick pea trial in adopted villages.

11. **SRS Nayagarh** Suggested that, KVK should focus on use of different bio-agent like trichocard in sugarcane cultivation and campaign & FLD programme should be include in the action plan.

12. The progressive farmers – cum- the members of the meeting suggested for bee keeping programme, floriculture programme etc.

Agenda 7 Chairman's Remarks

The Chairman emphasized to strength the linkage & convergence mode of work with the line deptt. To disseminate the technology in the district.

- He also suggested that the value addition of any commodity should be done in the nearby village.
- Bankers exposure visit should be made to KVK adopted villages training should be imparted through in-service training programme.
- He focussed on the documentation of the success stories of any KVK activities.
- After undertaking any trial, emphasis should be given for horizontal spread in the district.
- Value addition & marketing prosperity should be priority for mushroom.
