## PROCCEDING OF THE RESEARCH-EXTENSION INTERFACE MEETING

The Research-Extension Interface meeting of KVK, Nayagarh for the month of Aug'20 was held on Dt: 25.08.2020 at 3.00 PM in the Conference hall of KVK, Nayagarh under the chairmanship of Prof. P.K Sarangi, ADR, RRTTS (CZ), Bhubaneswar through video conferencing mode. The members present in the meeting are annexed herewith. Dr. Anil Kumar Swain, Sr. Scientist & Head, KVK, Nayagarh welcomed all the members and requested the chairman to start the meeting.

After a brief introducing remark, the Chairman asked to the Sr. Scientist & Head to start the meeting as per the agenda.

The Sr. Scientist & Head presented the overall achievement made by KVK during Kharif season for the current year as per the approved action plan 2020-21. The following issues were discussed during the meeting.

- I. 30 no.s of Training programmes were planned for Farmers and Farm women during the kharif season but due to the current pandemic situation (Covid 19) the training programmes are not started yet.
- II. 7 nos of FLD programmes were conducted (Other than Oilseed & Pulse) in different blocks of district in the kharif season.
- III. 4 nos of OFT programmes were conducted involving of 30 no. beneficiaries in different villages.
- IV. Sr. Scientist and Head appraised the member regarding success of different RF activities for seed, seedling, spawn and fish fingerling production at KVK farm.
- V. KVK has completed successfully the INM training for fertilizer dealers and Assessment of ASCI trainees on Mushroom grower.

After completion of the presentation, the Chairman requested the members to comment on the activities and invited suggestions. The suggestions were made by the members are listed below.

➤ The OIC, SRS, Nayagarh discussed on different varieties of sugarcane. Especially he discussed on "Sabita" variety which is a popular variety in the district and they have covered Nayagarh, Bhapur and Daspallla block as demonstration of Varieties like Raghunath, Sabita and recently released "Kalinga-386" sugarcane variety. He also discussed on cropping condition and vegetative growth of sugarcane which they are monitoring regularly in their demonstration fields.

- The Joint Director, O/o, DEE, OUAT emphasized on the dieases and pest attack in paddy after paddy transplanting in the farmers field and he suggested to the KVK Scientist to look after such situations specially during such pandemic COVID 19 situation. He also suugeted to work with Veterinary Deptt. Of the district in convergence mode in the KVK adopted villages. He requested to the SSH to show the different short videos prepared by KVK in their website though YouTube.
- ➤ The ADVO, Nayagarh discussed on their routine activities like AI programme, Vaccination programme in the district.
- The ADR focused on convergence activities towards progress of the district during such pandemic situation to convergence mode of work. He also discussed on different pesticides which should be applied in the paddy field, Damping condition in nursery beds (Open field) to avoid pests and diseases. Sr. Scientist of RRTTS suggested for different plant protection steps in rice due to the heavy rainfall.

The meeting was ended with the vote of thanks to the chair.
